CPVA Membership Terms and Conditions

1. An organisation or individual becomes a Member of CPVA upon completion and submission of this CPVA Membership Application Form, approval by the Directors of CPVA, payment of the annual Membership fee and inclusion on the register of members.
2. Effective term of membership is for one year and begins on the date that the annual membership fee is paid in full.
3. Membership of CPVA is automatically renewed every year unless members contact CPVA in writing before the annual renewal date that they wish to cancel their membership.
4. All membership fees and other amounts owed to CPVA are payable in AUD only.
5. Payment of membership fees not received within 14 days of becoming due may result in membership being considered lapsed and all services being suspended pending receipt of payment. Late payments (beyond 14 days) will incur a 10% processing fee.
6. For organisations, CPVA membership covers employees of the member company named on the application form only. Parent, subsidiary or related companies will need to join in their own right if employees of those companies wish to receive member benefits.
7. Only members that are up to date with payment of membership fees are eligible for the benefits associated with CPVA membership.
8. Company listings will be made live on the CPVA website (Members Directory and Service Finder) once membership takes effect (refer Point 1).
9. It is members' responsibility to provide the correct company information for the CPVA website and to inform CPVA of any changes to the information.
10. CPVA has no liability for advice provided through CPVA by members or any third parties.
11. Members will be notified in writing of changes to membership fees.
12. Terms and conditions may be updated from time to time, CPVA will notify members when any changes are made.
13.
